**Furthermore they declare**

- The agreement is divided into two parts:

**1<sup>st</sup> Part (agreement):** the spouses, by appointment, will declare that they want the separation or the divorce according to their agreements or that they want to modify previous separation/divorce agreements (already recorded in the civil registers). The day of the agreement, the spouses will have to decide for a new appointment that will take place after at least 30 days from the first one.

**2<sup>nd</sup> Part (Confirmation):** On the chosen date, the spouses will confirm the agreement and the civil registrar will record the separation and the dissolution of the marriage. The agreement must be confirmed. **Failure to appear is equivalent to failure to confirm the agreement.**
